OUTSTANDING PROJECT AWARD Requirements and Criteria

PURPOSE:

To recognize an outstanding project, research, or other significant contribution to Delaware and southern Chester County, PA

ELIGIBILITY

Project must:

- Be substantially completed during the year of the call for nominations or within a reasonable recent time period. Projects that are a major renovation, upgrade, expansion, etc. of an existing facility are eligible and will be evaluated based on the new work. Innovative programs are also eligible.
- The project or program must be physically located in **Delaware County or southern** Chester County.

CRITERIA FOR SELECTION

Each entry will be evaluated based on the following five categories, which are key elements of the project description text required in the electronic submittal described below.

1. Uniqueness and/or innovative applications of new or existing techniques	20%
2. Future value to the engineering profession and perception by the public	20%
3. Social, economic and sustainable development considerations	20%
4. Complexity	20%
5. Successful fulfillment of client/owner needs	20%
Total	100%

The selected project will be honored at the Chapter's **Thursday**, **February 20**, **2025** Engineer's Week Banquet, at Anthony's (Formerly Lamb Tavern, 865 W Springfield Rd., Springfield).

Award-Winning Project Principals should plan on a presentation not to exceed (10) minutes during the Banquet.

Entries must address each criterion and should identify unusual aspects of the project. Describe key challenges and solutions and new technology used. Consider all phases of the project, including the plan, design, construction, operation, and maintenance. The project's environmental, political, economic, social, and legal aspects may also be significant.

Present technical information in lay terms. Judges may not have expertise in the particular engineering discipline of the project.



Lifetime Achievement Award Call for Nominations

The Delaware County Chapter of PSPE is proud to present the Lifetime Achievement Award. The award is presented to an individual who has demonstrated the application of technical knowledge and skill to the advancement and betterment of human welfare.

The award is given for career achievement that has consistently demonstrated placing service above self. Individuals who have advanced the honor and standing of the engineering profession, and placed the public welfare above all other considerations are called to be nominated.

The details of the Award include:

- Candidate's long-term contributions through engineering to the local, state, national or global communities are to be honored with the presentation of this award. Candidates are requested to have a minimum of 25 years' experience in contributing to the field and community for whom they serve. Candidates must work or reside in Delaware County or southern Chester County.
- 2. Award recipients will be honored at the Chapter's February Dinner Celebration for Engineers Week.
- 3. Nominators are asked to prepare the nomination without the knowledge of the nominee. The nominee's family and/or colleagues should be asked to provide input for the nomination package.
- 4. A call for nominations will be issued via the Chapter Website, e-mail and direct mailings.
- 5. A committee, representing a cross-section of engineering disciplines, will make the selection. The committee is authorized to conduct research beyond the nomination form, to verify the accomplishments as presented in the nomination.
- 6. An award does not need to be made each year; it will only be presented if the selection committee determines that the nominations are of such quality as to justify the award.
